ORDER GRANTING PETITION FOR CONDITIONAL INTERPLEADER

This cause came to be heard on February 6, 2012, upon Petition for Conditional Interpleader, filed by Attorney Nicholas J. Owens, Jr, Attorney for Latasha Isom for claims asserted against her, upon statement of Attorney Nicholas J. Owens, Jr., Attorney John Booth Farese, Attorney Sean Akins, Attorney Bill Schneller, Attorney David Riley, and Attorney Rhea Tannehill (attorney for Latasha Isom personal injury claim), and, after reviewing the petition and receiving all evidence, the court finds as follows:

6) All Defendants have been given adequate notice of the hearing;


- 7) RL Isom (the father of Latasha Isom, RL Isom, Jr., Roderick Isom and ANPAC named insured) desires that the Court grant the petition for conditional interpleader and testified that it is in the best interest of his daughter, Latasha Isom for this Court to grant the petition;
- 8) John Booth Farese, guardian for Keasha Jeffries, guardian for Gabrielle Byers, guardian for Kirstin Byers, have each represented to the Court or testified that they believe that allowing the liability limits of \$300,000 to be deposited with the court would be in the best interest of their children. Further, each of them acknowledged and understood that if the Court grants the petition, this would bar any future claim against Latasha Isom, RL Isom, Joyce Isom and would end ANPAC's obligation to investigate, settle, or defend Latasha Isom, RL Isom or Joyce Isom or otherwise honor any claims arising out of the automobile accident of January 5, 2010.
- 9) Attorney Sean Akins and his client Tracy Riddle have represented to the court that they have no opposition to the petition. Further, they acknowledged and understood that if the Court grants the petition, this would bar any future claim against Latasha Isom, RL Isom, Joyce Isom and American National Property and Casualty Company for claims arising out of the automobile accident of January 5, 2010;
- 10) Attorney Todd Murrah and his client Holly Springs School District Workers's Compensation Carrier, Employers Assurance Company, represented to the court that they have no opposition to the petition. Further, they acknowledged and understood that if the Court grants the petition, this would bar any future claim against Latasha Isom, RL Isom, Joyce Isom and American National Property and Casualty Company for claims arising out of the automobile accident of January 5, 2010;
- 11) No other defendant minors or guardians have filed any answer to the Petition nor made any objection to the Petition in the court jacket or in open court. At the end of this order, on "Exhibit A" are the names of all unrepresented minors and guardians who appeared at the hearing;

- 12) There is an outstanding hospital lien from the Regional Medical Center in Memphis, Tennessee in the amount of \$2,000 for the claim of Gabriel Byers and Attorney John Booth Farese has represented to the Court that, after the hearing to determine the amounts due to each defendant, he personally guarantees that the lien will be satisfied immediately from the funds the Court awards to Gabriel Byers.
- 13) In light of the foregoing findings by the Court, after careful consideration, the relief requested in the Petition for Conditional Interpleader is in the best interest of all parties and is granted. All parties who appeared at the hearing are authorized and directed to execute the Full Release and Settlement of All Claims which will discharge Latasha Isom, RL Isom, Joyce Isom and American National Property and Casualty Company from all claims arising out of the automobile accident of January 5, 2010. Further, the claims of any party who did not appear are barred for failure to answer or appear at the hearing of February 6, 2012.
- 14) After execution of the releases by all defendants who appeared at the hearing, ANPAC shall deposit \$300,000 with this Chancery Court. Upon depositing of the \$300,000 with the Chancery Court of Marshall County, Latasha Isom, RL Isom, Joyce Isom and American National Property and Casualty Company shall be discharged from any and all obligations, tort or otherwise, arising out of the automobile accident in Marshall County on or about January 5, 2010. Further, ANPAC will be fully released of all its obligations to investigate, settle, or defend Latasha Isom, RL Isom, Joyce Isom or otherwise honor any claims arising out of the automobile accident of January 5, 2010.
- 15) After said funds have been deposited with the Chancery Court, the Court will set a hearing to determine how the \$300,000 should be equitably divided among the parties. At said hearing, any party seeking any portion of the \$300,000 is ordered to appear and bring medical records, bills and any other proof that would be relevant to assist the Court in determining a fair and equitable division of the interpleaded funds.



AGREED ORDER DISBURSING FUNDS

---

This cause came to be heard on February 6, 2012, upon Petition for Conditional Interpleader, filed by Attorney Nicholas J. Owens, Jr, Attorney for Latasha Isom for claims asserted against her, upon statement of Attorney Nicholas J. Owens, Jr., Attorney John Booth Farese, Attorney Sean Akins, Attorney William Schneller, and Attorney Rhea Tannehill (attorney for Latasha Isom personal injury claim), and, after reviewing the petition and receiving all evidence, the Court entered its order granting the petition.

The Court finds that all parties who have asserted claims to the \$300,000.00 are represented by attorneys. The parties and their attorneys have agreed to the division of the funds that are on deposit with the Chancery Clerk. The Court finds that the settlement is reasonable and in the best interest of all minors involved and should be approved.

~~NOW IT IS THEREFORE ORDERED, ADJUDGED AND DECREED AS FOLLOWS:~~

1) The Clerk of the Chancery Court of Marshall County, Mississippi, shall disburse \$100,000.00 (maximum benefits under the policy of insurance) to the wrongful death beneficiaries of Roddrick Isom as follows: \$25,000.00 to R. L. Isom, Sr.; \$25,000.00 to Joyce Isom; \$25,000.00 to R. L. Isom, Sr., and Joyce Isom, as General Guardians of R. L. Isom, Jr.; and \$25,000.00 to R. L. Isom, Sr., and Joyce Isom, as General Guardians of Latasha Isom. The funds paid to the Guardians for the use and benefit of the minors shall be deposited in a federally insured bank in a restricted certificate of deposit. The funds so invested and the accrued interest shall not be distributed to the minors until they reach the age of twenty-one years. The bank shall execute acknowledgment of receipt of the funds and of a copy of this Court's order. The bank shall enter its appearance and subject itself to the jurisdiction of this Court regarding the investment of these funds. The Court approves the fee agreement entered into by John Booth Farese, R. L. Isom, Sr., and Joyce Ann Isom, regarding the recovery of amounts on behalf of their minor children, and authorizes them to pay John Booth Farese according to the terms of the fee agreement.

2) The Clerk of the Chancery Court of Marshall County, Mississippi, shall disburse \$2,000.00 to Jurlann Parks, mother and natural guardian of Keasha Jeffries, for the use and

benefit of Keasha Jeffries. The guardian is ordered to use these funds solely for the use and benefit of the minor. The Court approves the attorney fee agreement entered into by John Booth Farese and Jurlann Parks, regarding the recovery of the amount on behalf of her minor child and authorizes her to pay John Booth Farese according to the terms of the fee agreement.

3) The Clerk of the Chancery Court of Marshall County, Mississippi, shall disburse \$60,000.00 to Christina Byers, as Mother and Natural Guardian of Gabrielle Byers, a minor. The funds paid to the Guardian for the use and benefit of the minor shall be deposited in a federally insured bank in a restricted certificate of deposit. The funds so invested and the accrued interest shall not be distributed to the minors until they reach the age of twenty-one years. The bank shall execute acknowledgment of receipt of the funds and of a copy of this Court's order. The bank shall enter its appearance and subject itself to the jurisdiction of this Court regarding the investment of these funds. The Court authorizes the guardian to pay \$2,000.00, as an agreed amount for a hospital lien of the Regional Medical Center in Memphis, Tennessee. The Court approves the fee agreement entered into by John Booth Farese and Christina Byers, regarding the recovery of the amount on behalf of her minor child, Gabrielle Byers and authorizes her to pay John Booth Farese according to the terms of the fee agreement.

4) The Clerk of the Chancery Court of Marshall County, Mississippi, shall disburse \$100,000.00 to Christina Byers, as Mother and Natural Guardian of Kirstin Byers, a minor. The funds paid to the Guardian for the use and benefit of the minor shall be deposited in a federally insured bank in a restricted certificate of deposit. The funds so invested and the accrued interest shall not be distributed to the minors until they reach the age of twenty-one years. The bank


shall execute acknowledgment of receipt of the funds and of a copy of this Court's order. The bank shall enter its appearance and subject itself to the jurisdiction of this Court regarding the investment of these funds. The Court approves the fee agreement entered into by John Booth Farese and Christina Byers, regarding the recovery of the amount on behalf of her minor child, ~~Kirstin Byers and authorizes her to pay John Booth Farese according to the terms of the fee~~ agreement.

- 5) The Clerk of the Chancery Court of Marshall County, Mississippi, shall disburse \$10,000.00 to Tracy Riddle and her attorney, Sean Akins.
  
- 6) The Clerk of the Chancery Court of Marshall County, Mississippi, shall disburse \$3,000.00 to Attorney William Schneller. Attorney Schneller shall allocate \$250.00 for the claims of each of his nine minor clients, Kelvontae Talley, Dimariggio Austin, Kelvin Ayers, Kamron Jones, Quenicy Jones, Julien Jones, Shirlitta Lesueur, Sharletta Lesueur, and Tralayah A. Pegues. Attorney William Schneller shall be entitled to \$750.00 attorney's fee. The parents and guardians of these named minors are ordered and directed to use said funds for the use and benefit of the minor.
  
- 7) The guardians of all minors identified in this order are authorized to execute releases to Latasha Isom, R. L. Isom, Sr., Joyce Ann Isom and American National Property and Casualty Company, in the form previously approved by this Court.


